

MINUTES OF THE ELECTORAL BOARD CANVASS November 6<sup>th</sup>, 2019

An open session meeting of the Orange County Electoral Board was called to order by the Chairman on Wednesday, November 6<sup>th</sup>, 2019 at 10:01 a.m. in RM 268, located at 146 Madison Rd., Orange, VA 22960 to conduct the Canvass of the November 5<sup>th</sup> General Election.

Attendees: Toni Warmack, Chairman; Vincent Basedow, Vice Chair; JoAnne Speiden, Secretary; Donna Harpold, General Registrar; Bridget Joyce, Elections Manager.

- I. *After being called to order, the board moved directly into a closed meeting to convene the Provisional Ballot Meeting at 10:03 am.*
- II. *Called back into open session at 10:27 am.*
  - a. The board voted to postpone Provisional Ballot Meeting until Friday, November 8<sup>th</sup>, 2019.
- III. *The open session of Canvass continues with the review of results of each precinct.*

101 Barboursville- Pollbook count 1216, Votes Cast 1217. Discrepancy: mistaken Poll worker error. Unsure of the discrepancy.

102 Gordonsville- Results tape matches reported results.

201 Lightfoot- Pollbook count 1201, Votes cast 1200. Discrepancy: One voided ballot

202 Mine Run- Results tape matches reported numbers.

301 Prospect Heights- Results tape matches reported numbers.

302 Unionville- Results tape matches reported numbers.

401 LGPS- Pollbook count 1117, Votes cast 1118. Discrepancy: One voter not properly checked in.

402 LGMS- Pollbook count 1034, Votes cast 1118. Discrepancy: A voter checked in but decided not to cast their ballot.

501 LOW Clubhouse- Pollbook count 1306, votes cast 1304. Discrepancy: two voters ripped up their ballots.

502 LOW Comm. Center- Pollbook count 1488, votes cast 1489. Discrepancy: Voter not checked in properly.

CAP- The results tape matched the reported results.

*The Canvass of Votes recessed for lunch at 11:36 am. Chairman motioned, secretary seconded.*

The board reconvened at 2:00 pm, recessed at 2:15. Continuation of Canvass will be Friday, November 8<sup>th</sup>, 2019. Provisional ballot Meeting will subsequently follow at 12:00 pm.
