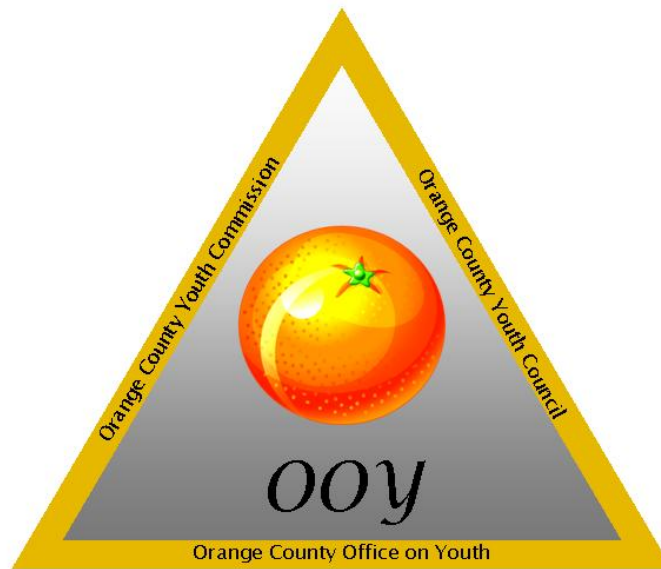

Types of Child Care

Care in Your Home

An in-home care arrangement occurs when someone cares for your child in *your* home. There are no licensing regulations for this type of care. The caregiver can be a relative, friend, or someone you pay to come to your home. For families with three or more children needing care, this type of care may be one of the least expensive.

In-home care is convenient and easy for both parents and children. Many home care providers can arrange their schedules to meet your needs. This means you will not have to get your child(ren) up in the morning to get them dressed, make breakfast, and leave the house. The provider comes to you. The children are usually cared for even when they are sick. Children may not be sick often as once they are in a school setting as they are exposed to illnesses by other children.

With in-home care, parents also have more control over the activities, equipment, and routines of their children since they are in their home. The children can receive more individualized attention especially if the caregiver is not expected to perform housekeeping duties. The children may enjoy this type of

setting since they will be in their own home surrounded by their own possessions.

The following disadvantages to in-home care must also be considered:

- Skilled in-home providers are difficult to find.
- You are dependent on the caregiver to be present and on-time.
- Your home utilities and food costs will be affected as the children will be home more during the day.
- Your children are not going to be around other children their age. Young children need to be around their peers to interact and learn from each other. Socialization is very important to develop skills for later in life.
- There are fewer opportunities for other adults to observe routine interactions between your caregiver and child(ren).

As an employer, record keeping is required to comply with federal and state tax and wage codes. You will need to become familiar with the requirements for minimum wage and income taxes. You can contact the Fair Labor Standards Act, the Internal Revenue Service, and Virginia Department of Taxation.

The in-home option is likely to be the most expensive for a single child family.

Child Care Centers

Child Care centers are established settings where children are cared for in a group, away from their homes, for all or part of the day. Center based care have many names:

- Child care center
- Pre-school
- Nursery school
- Cooperative center
- Learning center
- And more....

Center based care also have many different types of sponsors to include:

- Churches
- Hospitals
- Colleges
- Head Start
- Independent owners
- Private employers
- And more....

Some of these centers are to care for children in a safe, secure environment while their parents are working or attending school. Other centers are designed to prepare children for their early school years.

Many of these programs have an organized program of activities to help children learn. Some follow more formal plans. Others use a more informal program based on their day-to-day experience working with children.

You, as a parent, may be interested in center-based care if you want to keep your child in the same child care setting for an extended period of time if:

- your child needs special care because of physical or mental handicap or emotional problems
- you want certain educational or religious activities for your child
- in addition to care, your child will need medical or dental check-ups and mental health or social service appointments

A licensed child care center provides care for two or more children in a setting other than a private home. These centers are licensed by the Virginia Department of Social Services. They and are monitored with unexpected visits from Licensing Inspectors to ensure compliance with the standards as laid out by the State.

Hours of operation may vary between child care centers and pre-schools. Child care centers frequently offer extended hours and employ staff in shifts to cover these times. Child care centers attempt to accommodate most parents' work

schedules during the day. Most pre-schools offer only half-day hours. They are usually in the mornings.

Centers are able to provide safe environments for children and are not usually used for other purposes. Centers are also more likely to have staff and equipment to serve special needs children and offer the security of having more adults present or nearby. Children are usually grouped with children of their own age.

Center-based programs are often more expensive than Family Day Homes, especially for infants and toddlers. There are inherent changes that the child must adjust to in a center-based program. The turnover rate of staff and children may impact a child's sense of security in the setting. Centers may be more structured in the daily routine than other options.

Family Day Homes

A Family Day Home offers a home environment for a small group of children in the *caregiver's* home. The ages of the children may be the same or may vary. The caregiver may or may not be trained in child care and development. Family caregivers can be accredited through the National Association for Family Child Care (NFCC).

There are four types of Family Day Homes. They are:

- *Licensed Family Day Homes* – Provide care for up to twelve children (excluding the provider's own children and any children residing in the home). It occurs in the provider's home or the home of any of the children in care. This program is licensed by the Virginia Department of Social Services.
- *Voluntarily Registered Family Day Home* – Can serve up to five children (excluding the provider's own children and any children residing in the home). These programs are registered with an organization that is under contract with the Virginia Department of Social Services.
- *Family Day System Home* – Approved and monitored by an agency licensed by the State. Typically, these programs care for up to eight children, but some are approved for up to twelve (excluding the provider's own children and any children residing in the home).

- Unregulated Family Day Home – Not inspected by the State or its Designee. It can legally provide care for no more than five children (excluding the provider's own children and any children residing in the home) or no more than four children under the age of two (including the provider's own children and any children residing in the home) at any one time.

A Family Day Home is often the least expensive type of care, especially for infants and toddlers. A family setting is frequently warm and cozy and can be less intimidating for children as well as parents. The home is usually more flexible about schedules, rules, and less formal than a center. The child normally has fewer changes in providers as the primary caregiver is the owner of the business. The number of children in care is smaller than a center and therefore exposes children to fewer people and illnesses.

There may be drawbacks, however to Family Day Homes. These types of centers may be closed more often than centers due to the provider's vacations, appointments, and illnesses unless the provider has arranged for substitute care. There also may be more safety hazards for the provider to manage. Parents will need to be observant when choosing this type of program. The provider usually operates fairly independently, with infrequent observation by other adults.
