## Liberty Ride 2019 - Please READ

The Liberty Ride is a fundraiser for the Orange County Parks & Recreation Foundation, a 501(c)3 Organization whose mission is to help support the future of Orange County Parks & Recreation. The ride is organized by Orange County Parks & Recreation and Oakland Heights Farm. It is graciously hosted by James Madison's Montpelier. Generous support for this ride is provided by the Virginia Horse Council and Virginia Horse Industry Board.

The Liberty Ride will be held on **September 21, 2019** at James Madison's Montpelier, located at 13384 Laundry Road, Montpelier Station, Virginia 22957. Please enter at the main gate entrance. Maps and directions will be provided after registration. The ride begins promptly at 10am, so it is highly recommended that participants arrive before 9:30am. The Montpelier gates open at 8:30am. **ANYONE WHO ARRIVES AFTER 9:45AM MAY BE UNABLE TO PARTICIPATE.**

The length of the ride is between 7 and 10 miles round-trip (route may change based on weather and trail conditions), and the terrain is pasture land, wooded trails, gravel roads, and some paved roads, so please make sure horses are shod accordingly. We highly recommend that horses are shod, without shoes some horses have experienced fatigue on the gravel roads. **You know your horse best, so please consider the length of the ride, the terrain, and your horse's abilities before registering.** This is a group trail ride, there will be a trail master who will lead the ride. It is NOT self-paced. This first portion of the ride rounds the ellipse in front of James Madison's historic home. It is optional since it will expose horses to crowds of observers. If you do not wish to round the ellipse, wait at the start of the loop and rejoin the other riders as they come around. Lunch will be provided following the ride.

Pre-registration is **highly encouraged**. Registrations received after 9/6/19 will have a \$10 late registration fee added and cannot be guaranteed lunch. If mailing, the postmark must be 9/6/19 or earlier for \$40 registration (**note, this is earlier than the in-office deadline**). It is highly recommended that registrations are submitted well in advance of the date since **there is a limit to the number of riders who can participate**. Registration submissions should include the registration form, signed waiver, payment, and a copy of the Coggins report for each horse that will be participating. We will keep the Coggins report for our files, so participants are reminded not to submit their only copy. Participants should also bring a copy of their horse's negative Coggins report(s) to keep on their person throughout the event.

Payment is accepted in the form of cash or check. Cash payments must be taken in our office at 146 North Madison Road, Suite 205, Orange, VA 22960. Checks may be submitted by mail. All checks should be made out to the Orange County Parks & Recreation Foundation. We unfortunately cannot accept credit card payments. **Be sure to include all required registration documents with payment.** Thank You.

## RELEASE AND WAIVER OF LIABILITY

I hereby recognize that horses and/or any and all activities pertaining thereto are inherently dangerous and constitute a significant risk to myself and all members of my party. Such danger and significant risk also includes, but is not limited to, movement around and close proximity to said animals whether participating in equine activities or merely acting as a spectator or guest.

With this awareness and understanding that equine activities are dangerous and pose potentially serious risks of injury and/or death and damages to their participants, I and members of my party wish to participate in the September 2019 Liberty Ride horse ride event sponsored by Oakland Heights Farm, The County of Orange, The Orange County Parks & Recreation Foundation, The National Trust for Historic Preservation, The Montpelier Foundation (the "Event"). I understand that I and members of my party may be injured, die, or suffer damages in connection with the Event as a result of my negligence, the negligence of others, or through no fault of my own or anyone else due to the dangerous nature of the equine activity in which we are engaged. I also understand and acknowledge that horses, by nature, are often unpredictable and difficult to control. I hereby accept and assume any and all risks of injury (including death) or damage to myself, my property, and members of my party.

I hereby agree to waive and release any and all rights and claims of any kind for injuries (including death) or damages incurred by me or members of my party relating to the Event that I, my heirs, guardians, legal representatives or assigns may have or may in the future have against Oakland Heights Farm, or their owners, officers, directors, guests, agents, managers, employers, employees or any other persons associated with said organizations; The County of Orange, Virginia, (hereinafter the "County") or its employees, officials, or agents; The Orange County Parks & Recreation Foundation or its members, officers, agents, or other persons associated with said organization; any land or property owners whose property is incorporated in and/or involved with the Event, their family members, employees, agents, guests, or other persons associated with said landowners; and The National Trust for Historic Preservation & The Montpelier Foundation or their owners, officers, directors, guests, agents, managers, employers, employees, or any other persons associated with said organizations. This waiver and release applies regardless of whether the injury, death, or damages occur as a result of my own or anyone's negligence and/or any other cause arising out of participation in and/or observation of equine or other activities located on, associated with, or sponsored by Oakland Heights Farm, the County, The Orange County Parks & Recreation Foundation, The National Trust for Historic Preservation, The Montpelier Foundation, and/or all of the aforementioned parties.

I further agree to indemnify and hold harmless Oakland Heights Farm, the County, The Orange County Parks & Recreation Foundation, The National Trust for Historic Preservation, The Montpelier Foundation, the land or property owners, and all of the aforementioned parties from any and all claims I might make or which might be made on my behalf by others, arising from any activity relating to the Event. Furthermore, I agree to indemnify and hold harmless Oakland Heights Farm, the County, The Orange County Parks & Recreation Foundation, The National Trust for Historic Preservation, The Montpelier Foundation, the land or property owners, and all of the aforementioned parties for any injury, death, or damage to any personal property which might result from any equine and/or other activity, including, but not limited to, trail rides, lessons, horse shows, transportation to and from outside locations, social events, picnics, entertainment, open house, etc. sponsored by Oakland Heights Farm, the County, The Orange County Parks & Recreation Foundation, The National Trust for Historic Preservation or The Montpelier Foundation, or held on their behalf, whether such injury, death, loss, or damage occurs on the property of the Oakland Heights Farm, the County, The Orange County Parks & Recreation Foundation, or The National Trust for Historic Preservation, The Montpelier Foundation or property made available by other persons to the Oakland Heights Farm, the County, The Orange County Parks & Recreation Foundation, or The National Trust for Historic Preservation, The Montpelier Foundation and/or all of the aforementioned parties.

By signing this waiver and release, I accept notice of the provisions of §§ 3.2-6200 to 3.2-6203 VA Code Ann., which state the inherent risks in equine activities.

I have carefully read and understand the contents of this document and agree that I am giving up any right I have or might have in the future to sue or make a claim against Oakland Heights Farm, the County, The Orange County Parks & Recreation Foundation, any land or property owners whose property is incorporated in and/or involved with the Event, The National Trust for Historic Preservation or The Montpelier Foundation, and all the parties described in this waiver and release. It is my specific intent to give up these rights and hold harmless all of the aforementioned parties and I do so knowingly and voluntarily. If a participant is under eighteen (18) years of age, this release and waiver of liability must be signed by a parent or guardian who accepts full responsibility for the minor under the provisions of this agreement.

This waiver shall remain valid unless expressly revoked, in writing, with receipt acknowledged by Oakland Farms, the County, The National Trust for Historic Preservation, and The Montpelier Foundation.

It is highly recommended for safety reasons that a riding helmet be worn while engaged in equine activities.
