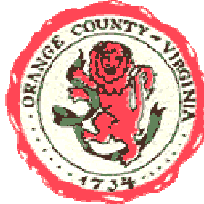

IMPORTANT NOTICE

AS REQUIRED BY THE CODE OF VIRGINIA, THE GENERAL REGISTRAR OF THE COUNTY OF ORANGE, VIRGINIA, HAS REMOVED FROM THE VOTER REGISTRATION RECORDS ANY PERSON WHO HAS NOT NOTIFIED THE REGISTRAR OF A CHANGE OF ADDRESS WITHIN THE JURISDICTION; OR, IF APPLICABLE, HAS FAILED TO PROPERLY TRANSFER HIS/HER REGISTRATION TO ANOTHER JURISDICTION WITHIN THE COMMONWEALTH OF VIRGINIA PURSUANT TO CODE; HAS FAILED TO RESPOND TO A CONFIRMATION NOTICE WITH INFORMATION THAT HE /SHE CONTINUES TO RESIDE AT THE REGISTRATION ADDRESS; HAS FAILED TO VOTE OR ATTEMPT TO VOTE IN ANY PRIMARY, SPECIAL OR GENERAL ELECTION AND, IF NECESSARY, CORRECT THE REGISTRATION RECORD; AND WAS PLACED IN AN INACTIVE STATUS SINCE PRIOR TO THE LAST TWO FEDERAL ELECTIONS. ANY PERSON NAMED ON THIS LIST HAS BEEN DELETED FROM THE VOTER REGISTRATION RECORDS AND IS INELIGIBLE AT THIS TIME TO VOTE PURSUANT TO VIRGINIA CODE 24.2-428.2, WHICH IS ATTACHED.

IF YOU FEEL YOU HAVE SATISFIED THE REQUIREMENTS OF 24.2-428.2 OF THE CODE, YOU MUST CONTACT THE GENERAL REGISTRAR'S OFFICE, LISTED ABOVE, TO CONFIRM YOUR ELIGIBILITY TO VOTE. THE OFFICE HOURS ARE MONDAY THROUGH FRIDAY, 8:30 A.M.-4:30 P.M. IF YOUR NAME APPEARS ON THE ATTACHED LIST, YOU ARE, AT THIS TIME, CONSIDERED INELIGIBLE TO VOTE.

FOR YOUR REFERENCE, A COPY OF 24.2-428.2 OF THE CODE OF VIRGINIA IS ATTACHED TO THIS LIST. SHOULD YOU HAVE ANY QUESTIONS, YOU ARE ENCOURAGED TO CONTACT THE GENERAL REGISTRAR'S OFFICE OR THE VIRGINIA STATE BOARD OF ELECTIONS AT (800) 552-9745.

§ 24.2-428.2. RETURN OF REGISTERED VOTER TO ACTIVE STATUS.

A REGISTERED VOTER SHALL BE RETURNED TO ACTIVE STATUS FROM INACTIVE STATUS IF, DURING THE PERIOD BEGINNING ON THE DATE THE VOTER WAS ASSIGNED TO INACTIVE STATUS AND ENDING ON THE DAY OF THE SECOND GENERAL ELECTION FOR FEDERAL OFFICE THEREAFTER, THE VOTER:

1. NOTIFIES THE GENERAL REGISTRAR OF A CHANGE OF ADDRESS WITHIN THE COUNTY OR CITY;
2. RESPONDS TO A CONFIRMATION NOTICE WITH INFORMATION THAT THE VOTER CONTINUES TO RESIDE AT THE REGISTRATION ADDRESS;
3. VOTES OR ATTEMPTS TO VOTE IN A PRIMARY OR A SPECIAL OR GENERAL ELECTION AND, IF NECESSARY, CORRECTS THE REGISTRATION RECORD; OR
4. TRANSFERS HIS REGISTRATION TO ANOTHER COUNTY OR CITY WITHIN THE COMMONWEALTH, PURSUANT TO § 24.2- 424 OR SUBSECTION E OF § 24.2-428.

IF THE REGISTERED VOTER FAILS TO TAKE SUCH ACTION ON OR BEFORE THE DAY OF THE SECOND GENERAL ELECTION FOR FEDERAL OFFICE AFTER THE VOTER WAS PLACED ON INACTIVE STATUS, THE GENERAL REGISTRAR SHALL CANCEL THE PERSON'S VOTER REGISTRATION.

THE GENERAL REGISTRAR SHALL POST AT THE COURTHOUSE OR HAVE PUBLISHED IN A NEWSPAPER OF GENERAL CIRCULATION IN HIS COUNTY OR CITY A LIST OF NAMES OF PERSONS WHOSE REGISTRATION HAS BEEN CANCELLED PURSUANT TO THIS SECTION. HE SHALL DELIVER OR MAIL, OBTAINING A CERTIFICATE OF MAILING, A CERTIFIED COPY OF THE LIST TO THE CHAIRMAN OF EACH POLITICAL PARTY IN HIS COUNTY OR CITY.
