

MINUTES OF THE ELECTORAL BOARD CANVASS of the November 2nd, 2021 General Election

An open session meeting of the Orange County Electoral Board was **called to order** by the Chairman on Wednesday, November 4th, 2021, at 10:00 a.m. in suite 204, located at 146 Madison Rd., Orange, VA 22960 to conduct the Canvass of the November 3rd General Election.

I. Provisional Ballot Meeting:

The Board postpones Provisional Ballot Meeting and continuation of CAP Write-In Results for Friday, November 5th, 2021, at 12:00 pm. Chairman moves to adjourn, all in favor at 1:05 pm.

The Board reconvened at 12:12 pm for continuation of Provisional Ballots, and Write-In Results, on Friday, November 7th, 2021, and was **called to order** by the Chairman on Wednesday, November 7th, 2021, at 12:12 pm. All were in favor.

WHEREAS, upon a motion made by the Chair of the Electoral Board, seconded by Vice Chair, and passed by a vote of Electoral Board, Electoral Board went immediately into closed session pursuant to 24.2-653 for the discussion of the 50 Provisional ballots at 12:20 pm.

WHEREAS, the Electoral Board of Orange County certify that in the closed session just concluded the only matters discussed were the qualifications of provisional voters, as directed by section **24.2-653** of the Code of Virginia, and as identified in the motion to close the meeting pursuant to the Virginia Freedom of Information Act. The Vice Chair Motioned, the Secretary seconded, all in favor.

Open session at 1:49 pm with results:
